LOAD OUT REQUIREMENTS:

- *Drivers are required to have PPE: hard hat, steel toed boots, FRC coveralls, and safety glasses. If possible, also an H2S gas monitor as one loading area will be an active well site.
- *Drivers MUST be clean Shaven.
- *Minimum of six (6) 3ft. deck pins made from channel iron or stronger.
- *Preferably no aluminum trailers due to weaker side rails. The site does not tier pipe in order to keep workers off the trailer deck. If aluminum is all that can be supplied, the transport company MUST provide support chains to connect the pins at approximately 18" height.

GENERAL SITE SAFETY:

- *3 point contact on and off equipment.
- *No jumping off equipment.
- *Drivers MUST be out of the work area while cranes are loading, preferably in truck or safe area designated by the work team.
- *Use spotter to guide equipment when other workers are onsite.
- *Ask the site supervisor for the designated smoking areas.
